Calendar Objective/Description

Privacy is a growing concern in today's world. Technological innovation in how individuals, organizations, and governments collect and share personal information and preferences have raised serious concerns. Data breaches have grown in frequency over the past decade exposing us to identity theft, financial fraud and intellectual property. This course introduces fundamental privacy concepts in a broad sense with emphasis on challenging and emerging research topics in privacy.

Topics

- Fundamental concepts of information privacy: major paradigms for understanding privacy, legal issues in privacy, data collection, use, disclosure, transformation, and retention, privacy obligations, and privacy regulations
- Contemporary issues in privacy: privacy concerns with networked technologies, anonymous communication protocols, social networks and social data, search engines and recommendation systems, personalization and privacy, web tracking, privacy in IoT, privacy and fairness in automated decision making, and big data and privacy
- Privacy metrics and privacy enhancing technologies: dataset partitioning, tokenization and randomization, K-anonymity, and differential privacy
