RATIONALE (must be included)

ENSC 413 was created as an undergraduate version of our graduate course ENSC 813 (Deep Learning Systems in Engineering). The course shares lectures with ENSC 813 and covers advanced concepts in deep learning theory and applications. For undergraduate students to be able to follow these graduate-level lectures, they need to have strong background in vector calculus (MATH 251), probability and statistics (ENSC 280), signals and systems (ENSC 380) and real-time software (ENSC 351). Here, "strong background" does not mean "merely passing" – the students really need to have strong command of the foundational knowledge, otherwise they would be set up for failure in ENSC 413. This is the reason we require a minimum of B in the prerequisite courses.
