Gerontology Post Baccalaureate Diploma Program

**Rationale for change:**

- 1) The reduction in credit hours to the SFU minimum (30) has been made to enhance faster completion of the program.
- 2) The reduction in required courses has been made to offer students greater flexibility in selecting courses that meet their educational and career goals. In addition, fewer required courses gives the Gerontology department greater flexibility in course scheduling, and in offering courses that have higher FTEs.
- 3) Although most students receive a waiver for the practicum component, the department recognizes that the practicum should have a credit value (3) as an elective in cases where a student completes the practicum.
- 4) These changes are based on tracking of student demand, feedback, and a departmental assessment of the PBD Program over several years.

Beedie School of Business – Bachelor of Business Administration

**Rationale for change:**

1. The Beedie School of Business (BsB) has gone through a program review to ensure program alignment with the school's calling. The review process established Program Level Learning Goals that reflected the calling and mapped the current curriculum against those learning goals. The review process identified gaps within the program and the different business areas within BsB modified courses or proposed new courses to better align the BBA to the school's calling.

2. In response to the 2019 to 2021 Beedie School of Business (BsB) Undergraduate Program Review and the growing call for the indigenization of SFU's curricula, the BsB Undergraduate Program Review Project Team is proposing the BsB Non-Business Elective Requirements for the undergraduate Business Major and Business Honours program.

This requirement is an elaboration of the current BBA requirement for students to complete a minimum of 36 units outside of the BsB and will direct students to learning experiences, outside of business that offers an Indigenous perspective.

3. Removing BUS 496 - The Beedie School of Business has undergone a program review to bring the BBA in alignment with the calling. One of the program changes includes the implementation of three Professional Development courses: Launch, Planning, Summit.

To implement, BUS 496 - Selected Topics in Business Administration (5) is being modified to BUS 496 – Professional Development – Summit (1).

As BUS 496 is no longer a selected topics course, this program modification is being put forward to remove BUS 496 - Selected Topics in Business Administration (5) from all program requirements.

### Major: Bachelor of Business Administration

Students admitted to the Beedie School of Business for the Fall 2017 term onwards must complete the Business Foundation Program within their first year.

During the first 60 units of the program, students will complete mainly non-business courses, which fall under three categories of courses. The first category consists of lower division requirements that are mainly foundation courses and prepares students for more advanced upper division business courses. The second category consists of courses completed to meet university requirements in writing, quantitative and breadth areas, **the Beedie School of Business non-business elective requirement**, as well as a minimum of 36 units, outside of the Beedie School of Business\*. These first two categories should be completed during the first 60 units.

In the third category, students choose courses that are based on intellectual interest or to achieve academic goals.

The last 60 units of the degree program consist of the core upper division business courses, at least one area of concentration, and lower and upper division electives. In total, students will complete a minimum of 120 units, which must include at least 45 units of upper division coursework.

Students are also required to complete the Business Career Passport program, which consists of six workshops to prepare them for their careers.

\*Courses not labelled as BUS or BUEC that are completed as part of the lower division requirements may be used toward the 36 units outside business.

<p><b>Name of Program or Name of Faculty</b> Actuarial Science</p>
<p><b>Rationale for change:</b> Over the past five years, the actuarial profession changed drastically with the introduction of more data science and predictive analytics. Future actuaries are expected to have better computing skills and be more knowledgeable about statistical methodology. This program modification addresses these concerns by (1) changing the computing requirements, (2) removing an older course, and (3) adding three existing courses discussing novel statistical methods. Also, (4) we are rearranging the selective lists to make sure that our students are asked to take the same number of units as before.</p> <ol style="list-style-type: none"> <li>1. CMPT 110 and 129 are not offered anymore. This forced us to review the lower-division computing requirements of our degree. By scanning the lower-division courses offered at Simon Fraser University, we selected two courses to replace this requirement: we are including explicitly CMPT 120 to the list of lower-division requirements (note that this course was already included implicitly for most of our students before as it was a prerequisite for CMPT 129, the recommended lower-division course for our program) and making STAT 260 and 261 required. This change will allow our students to be better prepared for some professional actuarial exams, which use the programming language taught in STAT 260 and 261. We are also adding STAT 360 to the last list of upper-division requirements to allow our students to further their computing training.</li> <li>2. We are removing ACMA 440. This will create more room to include more relevant topics in our curriculum, especially in light of the recent changes to professional actuarial exams and the move towards more predictive analytics.</li> <li>3. We are making STAT 350 and STAT 452 required. These courses cover parts of newly introduced professional actuarial exams (i.e., SRM and PA). The inclusion of these courses makes sure that our students are getting proper training about novel statistical methodology.</li> <li>4. We are reducing the number of courses—from four to three—in the last list of the upper-division requirements to account for the inclusion of an additional three units in the first list. We are also removing STAT 350 and 452 from the last list as they are now included in the first list of upper-division requirements. ACMA 395 and 490 are moving to the last list to reflect the fact that these courses are special topics and not as important as ACMA 470 and 475 for our students.</li> </ol>

### Admission Requirements

For admission, students normally complete each lower division required course in mathematics and statistics, or its equivalent, with a minimum C+ grade. Students are also normally required to have completed ACMA 101 and ACMA 201 with a minimum grade of C+ and have a cumulative grade point average (CGPA) of at least 3.0.

Achieving the minimum grade requirements will not guarantee program admission.

Students normally apply for admission in the term in which they complete ACMA 201.

### Courses for Further Credit

No student may complete, for further credit, any course offered by the Department of Statistics and Actuarial Science which is a prerequisite for a course the student has already completed with a grade of C- or higher without permission of the department.

### Computing Recommendation

Some experience with a high-level programming language is recommended by the beginning of the second year.

### Prerequisite Grade Requirement

Students must have a grade of C- or better in prerequisites for STAT courses. Students must have a grade of C or better in prerequisites for ACMA courses.

### GPA Required for Continuation

To continue in the program, students must maintain at least a 2.25 grade point average in MATH, STAT, MACM, or ACMA courses.



## Graduation Requirement

Students are required to complete a minimum of 44 upper division units including a minimum of 28 units in the major subject or field, and achieve a CGPA of 2.50 or better to graduate.

<p><b>Rationale for change:</b> Over the past five years, the actuarial profession changed drastically with the introduction of more data science and predictive analytics. Future actuaries are expected to have better computing skills and be more knowledgeable about statistical methodology. This program modification addresses these concerns by (1) changing the computing requirements, (2) removing an older course, and (3) adding three existing courses discussing novel statistical methods. Also, (4) we are rearranging the selective lists to make sure that our students are asked to take the same number of units as before.</p> <ol style="list-style-type: none"> <li>1. CMPT 110 and 129 are not offered anymore. This forced us to review the lower-division computing requirements of our degree. By scanning the lower-division courses offered at Simon Fraser University, we selected two courses to replace this requirement: we are including explicitly CMPT 120 to the list of lower-division requirements (note that this course was already included implicitly for most of our students before as it was a prerequisite for CMPT 129, the recommended lower-division course for our program) and making STAT 260 and 261 required. This change will allow our students to be better prepared for some professional actuarial exams, which use the programming language taught in STAT 260 and 261. We are also adding STAT 360 to the last list of upper-division requirements to allow our students to further their computing training.</li> <li>2. We are removing ACMA 440. This will create more room to include more relevant topics in our curriculum, especially in light of the recent changes to professional actuarial exams and the move towards more predictive analytics.</li> <li>3. We are making STAT 350 and STAT 452 required. These courses cover parts of newly introduced professional actuarial exams (i.e., SRM and PA). The inclusion of these courses makes sure that our students are getting proper training about novel statistical methodology.</li> <li>4. We are reducing the number of courses—from three to two—in the last list of the upper-division requirements to account for the inclusion of an additional three units in the first list. We are also removing STAT 350 and 452 from the last list as they are now included in the first list of upper-division requirements. ACMA 395 and 490 are moving to the last list to reflect the fact that these courses are special topics and not as important as ACMA 470 and 475 for our students.</li> </ol>
