



SENATE SUMMARY MEETING OF APRIL 3, 2023

1. **Report of the Chair**

The Chair recognized winners of the 2022 Awards for Excellence in Teaching: Nancy Forde, professor - Department of Physics; Brian Fraser, senior lecturer, School of Computing Science; Daniel Murdoch, senior lecturer, School of Criminology; Yuthika Girme, professor – Department of Psychology; Leanne Roderick, lecturer – Department of Geography; Joanna Woo, lecturer – Department of Physics; Amanda Watson, senior lecturer - Department of Sociology and Anthropology; and Diane Finegood, professor – Department of Biomedical Physiology and Kinesiology.

The Chair reported that a statement was issued last week regarding the honorary degree of Mary Ellen Turpel-Lafond stating that SFU has accepted the return of the Honorary Doctorate of Laws awarded to Mary Ellen Turpel-Lafond in 2016. The Senate Committee on University Honours reviewed the requests to revoke her honorary degree and determined there were appropriate grounds to proceed, and following the procedures for revoking an honorary degree recently passed at Senate, Turpel-Lafond was informed by the university that revocation was under consideration. She was provided an opportunity to return the degree voluntarily or to make representations on the issue at hand, and at that time Turpel-Lafond declined to make any such representation and opted to return the degree.

The Chair reported that SFU has been approached by the Royal Society of Canada to host their annual symposium in 2024. The theme for the Royal Society Symposium will likely center on community centered climate innovation.

The Chair reported that as part of the steps for the launch and implementation of SFU's new strategic plan, the University hosted a townhall on March 23rd for faculty and staff to ask more questions about the plan. It was attended by members of the executive team and had 250 people attend the online event.

The Chair thanked Senate for its discussion and collaborative resolution at the March Senate meeting regarding changes to SFU's Research Ethics Board (REB). At that meeting, Senate endorsed the appointment of a special joint committee comprised of one member of the REB, and two members each from the Board of Governors and Senate. Jeremy Snyder has been named as the representative of the REB, Dan Laitsch and Stephen Spector have been elected as representatives of Senate, while Carol Herbert and Michael McDonald will represent the Board. It is hoped that two meetings of the joint committee can be scheduled in the coming weeks to move towards a resolution.

The Chair reported that there has been discussion around reviving the Senate-Board of Governors retreat, with a potential date in either October or November. The topic for the retreat will be the SFU medical school.

2. Report of the Provost

The Provost reported that the Beedie School of Business and the Faculty of Environment have offered a Joint Major in Sustainable Business since 2014, but that changes that came through Senate were deemed sufficient enough for the University to go to the Degree Quality Assessment Board (DQAB) and seek confirmation that it would still be able to provide that degree. The DQAB confirmed that the degree has been approved under the new format.

The Provost reported that the provincial government has been talking about the distribution of tech seats for the last 18 months and an official announcement around this is expected in the near future.

In terms of the medical school, the Provost reported that work continues on the business case, focusing on the resources needed and gathering information from collaborating institutions and consulting teams to capture the requirements to do proper costing for the program. The University is also working with UBC to develop a complementary framework moving forward. Kris Magnusson, Dean of Education, has been partially seconded to support the medical program.

The Provost reported that progress continues in the search for the Dean of Graduate Studies, with three candidates being identified, and in the search for Dean of Education, with a shortlist being identified and interviews taking place in the next couple of weeks.
