Senate Library Committee

MEETINGS

The Senate Library Committee met 3 times during 2022/23:

- October 27, 2022
- February 27, 2023
- June 12, 2023

HIGHLIGHTS

October 27, 2022

- On April 1, 2023, the Library will move from VP Research and International to the Provost portfolio.
 At the same time, the operating budgets for the Vancouver and Surrey libraries will roll up to the library budget, rather than the VP External Relations.
- SFU copyright office launched a new central Copyright Clearance Fund. This fund covers copyright
 licensing costs for eligible reading materials used in teaching, providing free online access to the
 materials for students.
- The committee considered revised Terms of Reference for the Senate Library Committee. These will go on to SCAR and Senate for approval.
- Library has licensed a new software tool, <u>Covidence</u>, for the support of systematic and scoping reviews

February 27, 2023

- On November 14, 2022, the WAC Bennett Library was closed due the discovery of asbestoscontaining debris in the library. The Library re-opened on November 24th with the exception of the fifth floor which remains closed for repairs.
- Due to the closure of the 5th floor, the library moved high demand items to 6th floor. Where
 possible, links will be added to electronic versions of titles on the 5th floor collections. The Library
 also purchased additional copies of print for requested titles that are unavailable as e-books or
 unsuitable to use in e-book form.
- The committee heard about planning for library services for the proposed new SFU medical school.
- The committee received an update on the library budget for the 2022/23 year. The library's base budget was kept whole, however, there were reductions in support of currency exchange (\$700,000), and writing services (\$100,000).
- The committee received information about the creation of an accessibility plan to guide the library's work in identifying, eliminating and preventing barriers to access and participation for SFU students, faculty, staff and visitors. This plan will encompass services and facilities in all physical and virtual library spaces

June 12, 2023

- Library's Indigenous Curriculum Resource Centre was completed and a cedar brushing ceremony was held in the area.
- Bennett Library 5th floor will be closed for approximately one year for removal of asbestos- containing material on the ceiling. SFU received one-time funding of \$5 million from the province to help partially offset the cost of the project.
- A revised model for in-person research help was shared with the committee, to start in fall 2023. The plan includes a reduction in the number of walk-up in-person hours for research help. The desk will now be staffed for 2 hours per day at each library location. Students will be able to book research help appointments outside of these desk hours and zoom appointments can now be booked 2 hours in advance instead of the previous 24 hours. These changes reflect new patterns of use since the return to campus, with more uptake of virtual services and less in-person.
- Expansion of Fraser Library will include a new Fraser Library Digital Commons and Surrey Media Maker Commons.

MESSAGE FROM THE DEAN

It is my pleasure to share this report featuring highlights from the 2022-2023 year at the SFU Library. With the full return to campus, we were encouraged to see all three library locations fill up with energetic students once again, as they came to access collections and seek expertise. Of course, students also come to find spaces where they can collaborate, be inspired, create, contemplate, write, and much more. We are so pleased to see our libraries and programs full and animated once more.

As planning proceeds for SFU's proposed new medical school, we have been involved in work to detail what a medical library should look like in 2026 and beyond. Obviously, digital access to collections within and beyond the library will be critical, but so will bookable team rooms for small group work, tools at the point of need, support for systematic reviews, and virtual reality studios.

One of the challenges of the past year has been the discovery of asbestos-containing debris shedding from ceiling tiles in W.A.C. Bennett Library. In November 2022, the entire building was closed for ten days for testing and clean-up. We re-opened all but the fifth floor, and work will continue for the coming year on that floor for asbestos abatement. We prioritize the health and safety of library employees and users, and we are taking all possible steps to ensure continued access to collections housed on that floor while the work is underway. As you will read in the pages of this report, the SFU Library is thriving on all three campuses, and we continue to build connections with the community. You are warmly invited to visit – we will be delighted to see you.







Over the 2022-2023 fiscal year, Simon Fraser University Library has played a key role in the ongoing learning and research of the university through curation of our spaces and collections, and provision of critical expertise to SFU students, faculty, staff, and the wider community.

At our three physical branches, the W.A.C. Bennett Library at SFU Burnaby, the Samuel and Frances Belzberg Library at SFU Vancouver, and the Fraser Valley Real Estate Board Academic Library at SFU Surrey, and in our online platforms, we work to offer inclusive spaces for teaching, learning, research, and engaging with our community. This year, we continued renovations to create new learning spaces at Fraser Library and a physical site for our Indigenous Curriculum Resource Centre, and we look forward to official openings in the coming year. We build and curate rich, responsive collections, and provide expertise on research, writing, and learning through instruction and consultation. We also host writers and speakers in dynamic public events; this year included Lawrence Hill, Dr. Afua Cooper, Elamin Abdelmahmoud, and Angela Sterritt.

This fiscal year also saw the development and publication of a refreshed three-year strategic plan for the library, which calls on us to pause, reflect, and reorient our work. Affirming the essential work we continue to do in the areas of research, teaching and learning, and community-building, this plan also centres five priority approaches to ground our work:

- Relationships and community
- Reconciliation and decolonization
- Evidence-informed decision making
- Equity
- Climate action

As we are still in the early stages, we look forward to sharing more about this reflective, foundational work.

Through our deeply rewarding partnerships, our rich and responsive collections, and our indispensable expertise, SFU Library continues to advance the learning, research, and creativity of the SFU community.



Popular graduate student programming returns

A long-running graduate student program organized by the Research Commons, the Thesis Writing Retreat successfully returned to in-person in February 2023 after several years of virtual programming. The threeday writing-intensive event has a culture of deep care at its foundation. At each retreat, held once per semester, up to 32 graduate students from across disciplines gather for three days of dedicated writing time in a supportive environment. These three days include opportunities for accessing research and writing support, goal-setting and reflection, exploration of thesis-adjacent topics, and making interdisciplinary connections.



Responding to changing student needs

Throughout our return to on-campus learning and research, the library's services and spaces continue to evolve to meet student needs. The launch of a streamlined, mobile-friendly room booking software, coordinated by our Digital Services team, is widely used by students to book group study spaces and individual study rooms across all three campuses.

As an example of changing technology needs, upon discovering that students were increasingly unplugging computers in Bennett Library, library staff recognized a need for stations where students could connect their own laptops to large monitors. Designating 31 computer stations across several floors of the library as Bring Your Own Device stations, these popular work stations now enable students to use the stations in ways that better suit their needs.

SFU students and researchers shine in international partnership

A first-hand account of the Jacobite Rising of 1746, Robert Forbes' The Lyon in Mourning is a unique 18th-century manuscript comprised of transcribed conversations, narrative accounts, poems, letters, and more. Partnering on a SSHRC-funded research project with SFU's Research Centre for Scottish Studies and the National Library of Scotland, the library's Digital Humanities Innovation Lab (DHIL) contributes tools and methods to ongoing analyses of the individual stories and historical networks represented in the manuscript. "I have worked closely with the DHIL team on two projects now ... and have benefited so much from the expertise that they offer," shared Leith Davis, director of the Centre and professor in the English department.

The project's research activities included organizing a 2022 symposium in Edinburgh and publishing a special issue of the International Review of Scottish Studies. The collaboration also offers unique research and engagement opportunities for students, employing seven SFU students who have all actively participated in outward facing research, such as writing academic journal articles, presenting at ScotFest BC, and being interviewed on BBC Radio.

The Take a Break exhibit in Spring 2023 featured SFU Publishing students' work on display in all three library branches, exploring the format, form, and content of publications.

Researching how librarians teach key skills to graduate math students

During a recent study leave, Jenna Thomson focused on a research question that was of particular interest to her as the liaison librarian for SFU's mathematics department: how librarians provide information literacy support to math students as they make the transition to researchers. Her study builds on findings that show STEM students enter graduate programs underprepared to search, read, and interpret the literature in their field effectively – a set of critical research skills. Librarians from across North America responded to Thomson's quantitative survey and semi-structured interviews on librarianled graduate mathematics instruction, providing new insights into the extent of librarian teaching to this student group, and the tools, disciplinary resources, and research skills they teach.

Like Thomson, other SFU librarians and archivists engage in research activities, offering contributions to scholarship that demonstrate unique professional expertise as well as the grounded perspectives of research-practitioners. In Thomson's case, her research also equipped her with new information and strategies for approaching information literacy instruction with mathematics students at SFU.

Making SFU research widely accessible

In the fall of 2022, significant upgrades were completed to Summit, SFU's institutional repository, home to selected scholarship of SFU's faculty, students, and staff. Moving to a new platform with a modern look and feel, the refreshed site offers an improved search experience, including new options for filtering and browsing, as well as features for embedding video and other media. In addition, improved indexing with Google Scholar allows SFU's research to be more easily discoverable, including the university's theses. The upgrades to Summit support the flourishing of open access research, and improves access to SFU's research.

Voyages of exploration: a remarkable new collection

SFU Library's Special Collections and Rare Books is honoured by an extraordinary donation of a collection of 18th- and 19th-century books by Pacific and Arctic explorers such as James Cook, George Vancouver, and Roald Amundsen. These antiquarian books feature European efforts to document the geography, oceanography, botany, and zoology of the regions, including through maps and illustrations, and offer unique opportunities for learning and research on these colonial narratives of exploration.

This collection was painstakingly curated by SFU alumnus Frank Anfield for more than fifty years; in addition to donating his collection to SFU Library, Anfield established a generous endowment to support and maintain the collection over time, including digitizing some of the works, and to encourage use of the collection by students, researchers, and the public.
