Calendar Entry Change for Executive MBA

<p>Summary of change:</p> <p>Addition of BUS 694 and BUS 695 and removal of BUS 699.</p>
<p>Rationale for change:</p> <p>BUS 699 is being expanded to include additional sessions after the original 3 day retreat which allow students to continue their learning and build on topics and discussions introduced during the retreat throughout their EMBA program. In place of the previous retreat course, students will take two offerings (one per year) of Building Trust and Collaboration. The original BUS 699 will be replaced with paired courses, with BUS 694 covering Part I of the expanded coursework and BUS 695 is proposed to cover Part II of the coursework. The course focuses on team development and building capacity to address conflicts, improve communication, build trust within teams and organizations, and foster a more inclusive and supportive work environment. To reflect the increased scope of the course, the title and credits have been updated.</p> <p>Permission language has been updated under the program requirements at the request of the Dean and Vice-Provost of Graduate Studies.</p>

<p>Will this change impact current students? If yes, what is the plan for current students? Students will be able to receive credit for work that was being done informally for previous groups.</p>

The following program changes have been approved by the Department of Earth Sciences and are forwarded to the Faculty of Science Graduate Studies Committee for approval. These curriculum items should be effective for Fall 2024. Please include them on the next FGSC agenda.

This program change should have taken place at the time the number of credits for EASC 810 was increased from 0 to 3. The rationale for that course-credit change was: “Response to departmental review. Review panel recommended this 0-unit course be made 3 units in order for MSc students to more readily fulfill their 12-unit coursework requirements, with the goal of reduction MSc finishing times.”

For students to “more readily fulfill their...requirements” meant that the 3 units should have been counted toward the 12 units, not required in addition to the 12 units. The EASC GPC was not aware that a separate program change was required for this intention to be fulfilled, and this error was not caught at any stage of the approval process. The requested calendar change is intended to correct this error.

Please note that EASC 810 is similar to CHEM 802, which also counts toward the 12 required units for MSc students in Chemistry.
