


RE Centre for International Studies - Schedule A

Dear Dr Pinto

I write to you to request the formal dissolution of the Centre for International Studies, which has in effect been redundant for some time, as I reported last year. The Centre was set up before my own arrival at SFU as the Director of the School for International Studies, and the launching of the School's teaching and research programmes from Fall 2007. As the School became established the role that the Centre for International Studies had been set up to take on was taken over by the School. A further factor - and a part of the process to which I am referring - has been the retirement from the University of Professor Lenard Cohen, who was the Director of the Centre.

I request, therefore, that the Centre be formally dissolved.
