I am forwarding the attached new course proposal for Psychology 375 for the consideration of the Faculty of Arts Curriculum Committee. You will note that we are also dropping two courses (Psychology 371 and Psychology 372). The new course will be offered in place of Psyc 371 and Psyc 372. This change is being proposed because the current courses which offer a survey of psychotherapy techniques, largely through guest presentations by practicing psychotherapists, do not offer the students a systematic overview of the fundamentals of clinical psychology. The purpose of introducing this new course (Psyc 375) is to give students the appropriate methodological and theoretical overview of the field which is appropriate to the undergraduate level and is a necessary preparation for students who go on to further clinical training.

The Psychology Department recommends the following calandar changes for FACC's consideration. These changes are requestion for the 1988-89 calandar. In addition to these changes there are also some from last fall (including a new course, Psychology 375-3) which missed the annualization deadline and which should also be considered in September 1987.

1. Change of title: Psychology 385-3
From: Animal Behavior
To: Evolution and Social Behavior
2. Change of title: Psychology 485-5
From: Animal Behavior
To: Evolutionary Psychology and Sociobiology

Both of these changes have been requested by Dr. Crawford, who teaches these courses. The proposed titles more accurately reflect the content of the courses than do the current titles.

3. Change of Description: Psychology 335-3, Sensation I
From: Title: Sensation I
Course Description: Considers the capabilities of the visual and auditory sensory systems, and the sensory bases of experience with reference to the characteristics of stimuli, the receptor mechanisms, the processes of transmission, and the concomitant neurophysiological processes. Consideration is also given to the problems of response indicators and the measurement of sensory magnitudes.
To: Title: Sensation
Course Description: Considers the capabilities of the sensory systems, and the sensory bases of experience with reference to the characteristics of stimuli, the receptor mechanisms, the processes of transmission, and the concomitant neurophysiological processes. Consideration is also given to the problems of response indicators and the measurement of sensory magnitudes.

The deletion of "visual and auditory" is necessary because of dropping Psychology 336-3. When both 335-3 and 336-3 were offered the visual and auditory systems were covered in 335-3 and other sensory systems in 336-3. Because there was insufficient enrollment and teaching staff to offer both courses regularly, Psychology 336-3 was dropped and now Psychology 335-3 will serve as a general course covering the various sensory systems.

4. Addition to Course Description: Psychology 366-3

From: Treats language development from a psychological point of view. Topics include: origins of language in phylogeny, comparison between animal and human communication systems, and the acquisition of language in the first years of life.

To: Treats language development from a psychological point of view. Topics include: origins of language in phylogeny, comparison between animal and human communication systems, and the acquisition of language in the first years of life. Students who have take Psychology 365-3 may not register for Psychology 366-3.

This change is necessary because of the significant overlap between Psychology 365-3, Psycholinguistics (which has been dropped from the calendar) and the new course Psychology 366-3.
