## MEMORANDUM

Subject ELECTIONS TO SENATE AND RELATED  
COMMITTEES

Date JULY 9, 1973

- MOTION 1: "That the individuals nominated to the Senate Committee on Honorary Degrees, Senate Nominating Committee, Senate Committee on Undergraduate Studies, and to the Board of Governors be declared elected."
- MOTION 2: "That J. P. Daem be declared elected to the Senate Undergraduate Admissions Board as a student Senator to replace P. M. Doherty for balance term of office to September 30, 1973."
- MOTION 3: "That ballot elections now be held for the remaining memberships on the Senate Committee on Non-Credit Instruction, Senate Undergraduate Admissions Board, Senate Appeals Board, and the Academic Planning Committee."

### (Explanatory notes from the Secretary of Senate:

1. It will be noted that under the original S.73-78 there was call for nomination for election to the Academic Board for Higher Education in British Columbia but this is not included in the above. Unfortunately the original call was in error. R. D. Bradley was elected by Senate on July 10, 1972 to the Academic Board with term of office for three years. There is no requirement that the incumbent continue to be a Senator in order to remain on the Academic Board, and on previous occasions members have continued to hold office on the Board although they have vacated Senate office. The error in issuing the call is regretted. Had the call been correct, a ballot election would have been necessary as two nominations were received.
2. The nominations below were received following the distribution of the nominations made by the Senate Nominating Committee:
  - 1) Senate Committee on Non-Credit Instruction: Add A. L. Hollibaugh, nominated by M. E. Eliot Hurst.

- ii) Senate Undergraduate Admissions Board: Add, under one Senator at large, M. E. Eliot Hurst, nominated by A. L. Hollibaugh.
  - iii) Senate Appeals Board: Add M. E. Eliot Hurst, nominated by A. L. Hollibaugh.
  - iv) Academic Planning Committee: Add M. E. Eliot Hurst, nominated by A. L. Hollibaugh; K. K. Nair, nominated by K. E. Rieckhoff.
3. In view of the addition to the nominations made by the Senate Nominating Committee to the Senate Committee on Non-Credit Instruction, with one person to be elected for balance term of office to September 30, 1975 and two persons to be elected for balance terms of office to September 30, 1974, the ballot election will be across all four nominations, with the individual receiving the highest number of votes to hold office to September 30, 1975, and the two individuals receiving the next highest number of votes to hold office to September 30, 1974.)
