#### 6. <u>Other Business</u>

Senate received information with respect to the terms of reference and membership of the ad hoc committee.

In response to an inquiry as to why SCAR appointed the members of this committee rather than the President, Senate was informed that SCAR has responsibility for Senate committees and should be the one to name a committee reviewing a Senate policy. It was noted that the President is also the Chair of SCAR and expectations are that he and the committee will work closely together when selecting members.
