COURSE DESCRIPTION

Multicultural education is a process of comprehensive school reform and basic education for all students. It accepts and affirms 1) the doctrine of cultural pluralism that Canada and British Columbia subscribe to legislatively, 2) the various forms of pluralism (ethnic, racial, linguistic, religious, economic, and gender, etc.) that students and their communities and teachers represent, and 3) it challenges and rejects racism and other forms of discrimination in schools and throughout society.

Multicultural education is a progressive approach for transforming education. It is grounded in ideals of social justice, education equity, and a dedication to facilitating educational experiences in which all students reach their full potential as learners and as socially aware and active beings, locally, nationally, and globally.

Multicultural education permeates school curriculum and instructional strategies as well as the interactions among teachers, students, and parents, and it affects the very way schools conceptualize the nature of teaching and learning. In this course students will examine the origins, history and social context of multicultural education and anti-racism in Canada. Particular emphasis will be paid to a number of important concepts including multiculturalism, multicultural education, anti-racism education, racism, social justice, and the ways schools further existing social inequities.

COURSE OBJECTIVES

- To establish a comprehensive base of knowledge regarding the theory and practice of multicultural/anti-racism education.
- To become familiar with current issues in multicultural/anti-racism education.
- To reflect on what "culture" means to individuals and groups.
- To examine curriculum and learning materials for stereotyping and bias.
- To make explicit many of the ways teachers and schools further social injustice and inequities.
- To examine specific problems related to multicultural classrooms and schools.
- To explore how curriculum and school can be "multiculturalized".
