RE: Name Change Request: CMA Innovation Centre to CPA Innovation Centre

Background

In 2004 the Certified Management Accountants committed \$1,000,000 to fund the CMA Centre for Strategic Change and Performance Management.

In July 2012 the Canadian Institute of Chartered Accountants and the Certified Management Accountants Canada boards approved the commencing of work to establish the Chartered Professional Accountant as the national unifying body of the CA, CGA and CMA designation. CPA Canada was established by CICA and CMA Canada on January 1, 2013, and CGA-Canada integrated with CPA Canada on October 1, 2014, completing the unification of Canada's accounting profession at the national level. In BC, the Chartered Professional Accountants legislation was passed in June 2015.

Recommendation

At the request of CPA Canada, we propose that the CMA Innovation Centre be renamed to reflect the transition from CMA to CPA. This name change is necessary as the CMAs no longer exist. At the current level of funding it is expected that the Centre will remain active for at least two more years.

We recommend that the CMA Innovation Centre be renamed to the **CPA Innovation Centre**
