Calendar Entry Change

Rationale for change:

To create greater accessibility to opportunities such as student exchanges and study abroad. By clarifying the 3-unit requirement on 400-level Business courses, students will have more flexibility to use courses taken on approved exchange towards degree requirements.

UPPER DIVISION REQUIREMENTS

In the last 60 units, students must complete a minimum of 45 upper division units, of which a minimum of 36 units must be in BUS or BUEC courses.

The minimum 36 upper division units in business must include the following.

- -all core courses (see Core Courses below)
- -an area of concentration (see Areas of Concentration below)
- -at least three 400 division BUS or BUEC courses, each worth a minimum of three units (excluding practicum courses and BUS 478). Any 400 division BUS or BUEC course completed at SFU must be worth a minimum of 3 units to be used to fulfill this requirement. These courses may be used toward the requirements for the area(s) of concentration. At least one of these 400 division BUS or BUEC courses must be completed at Simon Fraser University.

Further, upper division courses in any discipline must be completed to bring the total upper division credit to 45 units minimum.

This course is an extension of BUEC 232. It develops and applies the quantitative models that are most directly relevant to business decisions. Beginning with material on multiple regression and forecasting modeling, the course moves on to decision analysis, business simulation, quality control, and an introduction to optimization. Prerequisite: MATH 150, MATH 151, MATH 154, or 157; BUEC 232 or STAT 270; 60 units. Quantitative.

RATIONALE (must be included)

Previously BUEC 232 and STAT 270 were coded as prerequisites on BUS 336 as we had language in the calendar indicating that either would be accepted in the Business program. However, this language has been removed from the calendar as it was determined to be advisory and therefore not appropriate for the calendar.

Since prerequisites coded on the course need to match those listed in the calendar, STAT 270 has been removed as a prerequisite for BUS 336 even though we have considered them equivalent and allowed STAT 270 as a prerequisite in the past. This language change in the prerequisite would make official what we have been doing.

BUS 483 - Introduction to Employment Law For Business (3)

Provides a solid foundation for students in understanding the legal obligations, statutes, and limitations within provincial legislation that govern employment relationships in non-union contexts. Additionally, will explore the legal aspects of matters of particular importance for managers faced with human resource policy decisions. Prerequisite: BUS 381-BUS 393, BUS 360W and 60 units.

BUS 393 (Commercial Law) is a more relevant prerequisite for this course as it provides a general background before students delve into the more specific aspects of employment law. Students who have taken BUS 393 prior to BUS 483 in the past have demonstrated a clearer understanding of the concepts needed for success in BUS 483.

Rationale for change:

To create greater accessibility to opportunities such as student exchanges and study abroad, additional areas of concentrations, minors in other faculties, and certificates. Within the Business Major and Honours requirements, non-Business electives will now be reduced in order to allow more flexibility in programming, while still requiring students to take courses outside of business.

Program Requirements

Students complete at least 120 units, within which:

Students must complete a minimum of either 15 12 courses (each worth three or more units) or 45-36 units, outside the Beedie School of Business*. Within the 15 12 courses, or 45-36 units, students must also meet the University requirements for breadth — 6 units labelled as Breadth-Humanities, 6 units labelled as Breadth-Science, and 6 units labelled as Breadth-Social Science, and 6 units of additional breadth that may or may not be labelled. *Courses not labelled as BUS or BUEC that are completed as part of the lower division requirements may be used toward the 15 12 courses or 45-36 units outside business.
