

## SENATE SUMMARY MEETING OF APRIL 9, 2018

## 1. Report of the Chair

The Chair reported that Wendy Chun holds the second chair awarded to SFU as part of the *Canada 150 Research Chairs Program*. She is going to join the School of Communications from Brown University to hold a Chair in *New Media*, where she hopes to develop coalitions that can create new approaches to digital democracies. There are only 25 chairs in total funded under the program which was created in celebration of Canada's 150th anniversary. SFU was successful in securing two of those 25, with Caroline Coljin being previously announced to hold a Chair in *Infection, Evolution and Public Health*.

The Chair reported on recent research grant successes:

- Ruth Lavergne, principal investigator for one of three SFU Health Science research projects, was recently awarded \$1.25M in *CIHR* funding to examine how changes in the primary care physician work force are contributing to patient access problems.
- Scott Venners, in collaboration with the *First Nations Health Authority*, will be leading a 4-year \$700,000 population health initiative that will train four SFU indigenous graduate students in population health research methodology.
- Behraad Bahreyni from Mechatronic Systems Engineering has been awarded a \$288,000 NSERC Collaborative Research and Development Grant for research in particle acceleration micro sensors for sonar applications, for which he is also receiving \$144,000 in funding from Ultra Electronics Maritime Systems Inc.
- 22 SFU researchers from 12 departments were awarded 2017 SSHRC Insight Grants. They received a total of \$3.56M in research funding based on a success rate of 52.4%, well above the national average of 47.3%.
- Anne Marie Nicol of the Faculty of Health Sciences was awarded \$2.7M from the *Canadian Partnership Against Cancer* for the *CAREX Canada project*.
- Frank Gobas from the School of Resource and Environmental Management has been awarded \$338,000 to collaborate on a project funded by the European Chemical Industry Council entitled Improved Characterization of Portioning and Biotransformation for Screening Organic Compounds for the Potential to Bioaccumulate in Airbreathing Species.
- Jonathan Choy from the Department of Molecular Biology and Biochemistry was awarded \$295,000 by the *Heart and Stroke Foundation of Canada Grant-in-Aid Program* for his project *Immune and Vascular Effects of IL-6 in Transplant Arteriosclerosis*.

• Victoria Claydon from the Department of Biomedical Physiology and Kinesiology was awarded \$197,000 by the *Heart and Stroke Foundation of Canada Grant-in-Aid Program* for her project *Mechanism and Management of Pediatric Syncope*.

The Chair reported that Kristy Duncan, *Minister of Science* and *Minister of Sport and Persons with Disabilities*, visited the Burnaby campus on April 9th, where she toured the *ROSIE* lab and the *Autonomy Lab* in the Faculty of Applied Sciences.

The Chair reported that Joy Johnson, Vice-President Research, and Sarah Lubik, Director of Entrepreneurship, have been selected to speak at the 2018 #BCTECH Summit.

The Chair reported that in his role as President, he led an SFU delegation to Singapore in late March to participate in the 2018 *Asia-Pacific Association for International Education Conference and Exhibition*, which SFU will host in 2020. This is a major conference attracting over 2,000 attendees from around the world. The delegation also stopped in Taiwan on the way back to connect with some academic partners, sign memoranda of understanding with key university partners and host an alumni reception.
