4. Business Arising from the Minutes

i) At the April meeting Senator Hendrigan asked a question about how to encourage or incentivize the uploading of faculty journal articles into Summit. Senate was informed that there are a number of initiatives being worked on to encourage faculty to deposit their research publications into Summit. This includes encouraging faculty members to obtain an Orcid iD, reminding faculty members of the Open Access Policy, the ongoing development of several tools to access other publication databases currently used by SFU authors, and the continuing work on a research enterprise system that could later be linked to CV-management tools. Although it will be easier to deposit articles once these tools have been implemented, it was noted that this does not guarantee an increased deposit rate.

5. Report of the Chair

The Chair acknowledged the recent passing of Ali Dastmalchian, Dean of the Beedie School of Business. Ali will be deeply missed by the SFU community and by his colleagues around the world. Condolences have been extended to his family and the University will be looking for ways to honour his remembrance and the important work he did.

The Chair reported that SFU is in the midst of its month of welcome to students, with activities taking place to welcome students in the faculties and also through Student Services. It was noted that it's important, especially in these times, to provide students with creative opportunities to engage with the University and to engage with one another.

The Chair, in her role as President, noted that it's an honour to serve as SFU's tenth president and recognized that it's a challenging time to take on the presidency. Thanks was offered to faculty, staff, and students for the incredible work done over the past months. Though it is common for a new president to embark on a strategic planning process, it was noted that now is not the time to do so. Focus should be given to taking care of the University and ensuring the continuance of offering high quality programs. As such, the Chair identified the following priorities in the coming months:

• To ensure that SFU is a resilient and adaptive institution that can thrive despite challenges and be able to recognize the opportunities that lie ahead.

- To ensure SFU students are provided with a positive, healthy and exciting environment in which to learn and thrive.
- To deliver on the recommendations of the Aboriginal Reconciliation Council's report and to ensure that SFU is a place where indigenous people can flourish.
- To focus on equity, diversity, inclusion, and antiracism to ensure that SFU is a community where all feel welcome, safe and accepted.

8. Other Business

i) Institutional Research and Planning (IRP) Report: 2019/20 Grades Report (S.20-104) Senate received the 2019/20 Grades Report for information.

Zareen Naqvi, Director - Institutional Research and Planning, was in attendance to respond to questions.

A question was asked as to how the implementation of a pass/fail grading system impacted grade calculation. Also, a comment was made noting that it would be useful to see a breakdown of grades by term, and also by department. Senate was informed that work is being done to break down grades by term, especially the summer and fall terms compared to the spring term. In terms of how pass/fail grades impacted grade calculation, because pass/fail grades were not assigned a numeric grade, they were removed from the calculation. This is one of the reasons grades were inflated in 2019.

A question was asked if there any constraints that would affect next year's ability to properly account for the anomalous nature of the data from this year. Senate was informed that breaking down the grades report by term will help to explain some of the differences existing between 2020 and other years. Also, work is being done to look at some connections between grading policy and other kinds of performance measures used for students. Once that is done, consideration will be given on how best to present this information in next year's report.

ii) Institutional Research and Planning (IRP) Report: 2019 Undergraduate Student Survey (UGSS) Report

Senate received the 2019 Undergraduate Student Survey (UGSS) Report for information.

Zareen Naqvi, Director - Institutional Research and Planning, was in attendance to respond to questions.

A comment was made noting that it would be useful to see the data more specifically broken down to provide indications of how certain patterns occur, particularly with respect to gender, year of study, and whether students are domestic or international.
