Motion: "That SCAR approves the "Go Forward" Principles outlined below and makes available to Senate the attached Spreadsheet to Senate for Senate's information."

### **Updated Spreadsheet**

In follow-up to the November 23 SCAR meeting, enclosed for your review is an updated spreadsheet listing the policies currently posted on SFU's Policy Gazette: Policies and Procedures - Simon Fraser University (sfu.ca)

At your request the spreadsheet previously provided has been updated to include a column showing the Policy Authority for each policy.

The revised spreadsheet also now includes the date by which the policy is scheduled for review, where such date is currently explicitly mandated. The University Secretariat is in the process of establishing proposed mandated review dates for each of the remaining policies (except the AD9 and AD10 employment policies) based on the principle that every University Policy should be reviewed at least once every five years. The factors the Secretariat is applying to prioritize these policies for review include:

- level of urgency (e.g., legal compliance; impact to the institution)
- thematic coherence (e.g., inter-related policies should be reviewed concurrently for alignment)
- anticipated scope of the review (e.g., housekeeping changes or substantial overhaul)
- currency (when was the adequacy and relevance of the policy last considered; not all policy reviews result in revision and it is the "date last revised" that has historically been tracked)
- policy authority (workload impact within a specific unit or under a specific policy authority's portfolio)

The University Secretariat will provide further information about anticipated mandated review dates in due course.

# **Principles**

At our November 23<sup>rd</sup> meeting members of SCAR asked about the principles upon which the "Go Forward" column is based. Those principles are as follows:

- 1. Under s.37 of the *University Act*, the academic governance of the university is vested in the Senate. Policies within the academic governance jurisdiction of Senate either originate through a Senate committee or through an administrative unit of the university, and come forward to Senate for approval. These policies are approved by Senate and are recommended to the Board of Governors.
- 2. Under s.27 of the *University Act*, the management, administration and control of the property, revenue, business and affairs of the university are vested in the Board of Governors. Unless a policy falls within one of the following categories in section 3 below, or falls under the authority delegated by the Board to its Human Resources Committee, it he policy will be approved by the Board after community consultation without involving Senate.
- 3. In some subject areas, the *University Act* requires the Board to seek the approval of Senate, or to consult with Senate, or to consider recommendations from Senate. Specifically:

## Board, with the approval of Senate

- a. Under s.27(2)(f) of the Act, the Board is empowered to establish procedures for the recommendation and selection of candidates for specified positions, but the Board is required to obtain Senate's approval of those procedures. These are provided to Senate for approval and recommendation to the Board of Governors.
- b. Under s.27(2)(k) of the Act, the Board is empowered to provide for chairs, institutes, fellowships, scholarships, exhibitions, bursaries and prizes that that the Board and the Senate consider advisable; and under s.37 of the Act, Senate recommends to the Board the establishment or discontinuance of chairs, fellowships, prizes, etc. These policies are provided to Senate for approval and recommendation to the Board of Governors.
- c. Under s.27(2) (i) and (j) of the Act, the Board considers recommendations from Senate and, with the **approval** of Senate (and subject to s.29) provides for the establishment of the faculties and departments the Board considers necessary. These policies originate with Senate or are provided to Senate for **approval and recommendation** to the Board of Governors.
- d. Under s.27(2) (r) of the Act, the Board determines, with the approval of Senate, the number of students that may be accommodated in the university or in any faculty and makes rules considered advisable for limiting the admission or accommodation of students to the numbers so determined.

These policies originate with or are provided to Senate for **approval and recommendation** to the Board of Governors.

#### Board, in consultation with Senate

- e. Under s.27(2)(d) of the Act, the Board, in consultation with Senate, is empowered to maintain and keep in proper order and condition the real property of the university, to erect and maintain buildings and structures that the Board considers necessary, and to make rules respecting the management, government and control of the real property, buildings, and structures. These policies are provided to Senate for consultation.
- f. Under s.27 (2)(e) of the Act, the Board, in consultation with Senate, is empowered to provide for conservation of heritage sites of the university. These policies are provided to Senate for consultation.
- 4. In some instances, although the *University Act* does not explicitly require Senate involvement, thea Policy Authority may wish to seek input and advice from Senate before taking a policy forward to the Board for approval. At the sole-discretion of the Policy Authority, such a policy may be provided to SCAR, with a request that it be taken forward to Senate for input and advice. It is up to SCAR to determine whether such a policy will go forward to Senate, and if so, whether for advice or simply for information.
- 5. In some instances, although the University Act does not explicitly require Senate involvement, a Board policy has university-wide application and impact and as such is of interest to the university community as a whole (for example, GP16 Control of Smoking and Other Tobacco and Cannabis Use on Campus) or may be of particular interest to members of Senate (such as GP04 Unscheduled Cancellation of Classes). In such cases the policy should be provided to SCAR. It is up to SCAR to determine whether such a policy will be circulated to Senate for information.

I welcome your input on these principles and I look forward to discussing them with you when SCAR next meets on December 14, 2021.
