RE: Graduate General Regulations (GGR) Revisions: GGR 1.5.2



At its meeting on December 7, 2021 SGSC reviewed and approved the revision to GGR 1.5.2 (Competency Grading Basis). The proposal is to remove the Complete (CO) grading basis and change all existing graduate courses from In Progress/Complete to the Satisfactory/Unsatisfactory (S/U) grading basis. In Progress (IP) will remain a grade designation. This gives rise to the following motion, effective **Fall 2022**:

RE: Remove IP/CO as standalone notations

Since transitioning to Satisfactory/Unsatisfactory (S/U) for thesis and capstones, the use of the notation Complete (CO) is limited. The recommendation is to remove In Progress/Complete (IP/CO) as a “grading basis” and promote using IP in all grading schemes (not just in IP/CO graded courses).

Courses that that currently have IP/CO should have their grading basis changed to S/U.

- 1) "Satisfactory" when the student completes all course requirements;
- 2) "Unsatisfactory" when the student is required to withdraw;
- 3) "In Progress" may still be used if the course is going to span over multiple terms or if the student decides to leave the program without being required to withdraw.

<p>Summary of change:</p> <p>The proposal is to remove the Complete (CO) grading basis and change all existing graduate courses from In Progress/Complete to the Satisfactory/Unsatisfactory (S/U) grading basis. In Progress (IP) will remain a grade designation.</p>
<p>Rationale for change:</p> <p>The In Progress/Complete (IP/CO) grading basis does not accurately reflect the possible graduate course outcomes. If students complete graduate coursework, but do not meet course learning outcomes, an IP is not an appropriate grade notation. Satisfactory/Unsatisfactory (S/U) grading basis better encompasses possible course outcomes for students.</p>
<p>Effective term and year:</p> <p>Fall 2022</p>
<p>Will this change impact current students? If yes, what is the plan for current students?</p> <p>Students will receive S/U grading on their transcript.</p>
