In this role, I have started a mentorship program for first-year female engineering students and was involved in advising the Engineering Department's Equity Committee on the students' perspective when they were preparing their list of recommendations to the department on increasing the role of women in engineering. I was also a member of the Engineering Undergraduate Student Society in my first year at SFU.

In the past three and a half years at SFU, I have realized that a student's merit is often determined by his or her GPA, but at the same time, there are many flaws with the way that students are evaluated, often resulting in unfair grades. I especially see this problem in the engineering department, where many students are very competitive and would do anything to get a good grade. In this close-knit program, students often have access to material from previous offerings of a course. There have been many cases where professors re-use material for homework

assignments and even exams, giving an unfair advantage to those who have access to these "course files". To further compound the problem of academic dishonesty in the engineering department, not only do the students not uphold the principles of academic integrity, but also in some cases the professors promote academic dishonesty.

Having been exposed to this widespread academic dishonesty in my department, I am very concerned that it has degraded the value of my education. Therefore, I am passionate about putting an end to academic dishonesty at SFU. I believe that this should be done by educating the students and instructors about proper academic conduct and enlisting members of various faculties to be in charge of promoting academic integrity in their departments.
