

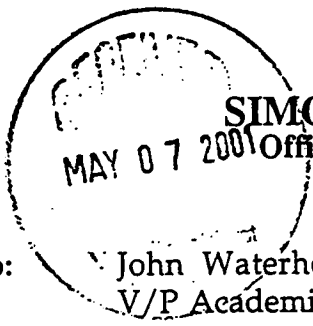

Mission Statement, Centre for Labour Studies

The activities and programs of the Centre for Labour Studies are intended to promote teaching, research, and community programming in labour studies. The Centre facilitates research, publications, instruction, community projects, colloquia, conferences, visiting speakers, and international relationships. In the pursuit of these objectives, the Centre seeks to provide support to existing individual, departmental, and cross-disciplinary activities at Simon Fraser University in the area of labour studies.

Governance Statement

The Centre for Labour Studies is a Schedule A Centre and comes under the direct authority of the Dean of Arts.

The Centre for Labour Studies is housed in the Department of History.

The Director of the Centre shall be appointed by the Dean of Arts on the recommendation of the Centre's Advisory Committee. The term of office shall normally be for three years.

In the absence of the Director, an Acting Director may be drawn from the Centre Advisory Committee.

The activity of the Centre shall be guided by an Advisory Committee made up of seven SFU faculty members and up to four representatives from the community. The community representatives will normally consist of one representative from the Canadian Labour Congress, two from the BC Federation of Labour, and the labour representative on the SFU Board of Governors. Members of the Advisory Committee will be appointed by the Dean of Arts on the recommendation of the Director. Appointments shall be for a three year term.

The Advisory Committee shall be chaired by the Director of the Centre. Meetings will normally take place once a semester.

The administration of the Centre and its academic programs shall be governed by an Executive Committee made up of the SFU faculty members of the Advisory Committee. The Executive Committee shall be chaired by the Director of the Centre.
