With the support of the Dean of Graduate Studies, a number of years ago the History Department stipulated that the expected MA completion time was five semesters for full-time thesis students, and three semesters for full-time project-option students. Part-time students can take an extra year. These requirements appear in the department's Graduate Brochure, but we now wish to add them to the Calendar. The rationale for having such a time limit is quite simply to encourage students to complete their degrees within a reasonable amount of time. Though the policy has not been rigorously enforced, our completion times have improved dramatically since it was introduced. The reason we wish to add this policy to the calendar is to ensure that students and supervisors realize that it has the university's sanction.

The exact wording of the calendar text which we wish to add is as follows:

"Full-time thesis-option students are expected to complete their degree requirements in a maximum of five semesters, and project-option students in three. Part-time students may take one additional year for completion."
