The Department of Criminology wishes to put forward a simple addition to the undergraduate calendar entry without change in the requirements for a major in criminology. The proposed change adds a new plan (Plan F) to the five plans already listed in the calendar.

Rationale

In 1975 and again in 1976 the Criminology Department advertised its' course offerings in the areas of law and justice. This attracted a number of students interested in legal education and aiming at a law career. It is now felt that it would be desirable to set up a suggested study plan grouping the required and elective courses at both the lower and upper levels for students interested in majoring in criminology with a concentration on legal studies. As can be seen from the courses listed in the proposed plan, the plan does allow the student to acquire a strong interdisciplinary background in addition to the solid legal education and training it provides.

The new plan has been approved by the Criminology Department Undergraduate Curriculum Committee.

I hope that this matter will be placed on the agenda of the forthcoming meeting of the Undergraduate Curriculum Committee.

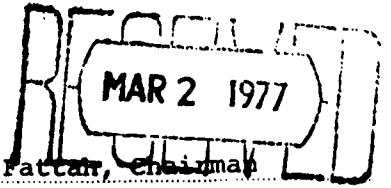

In 1975, and again in 1976, the Department of Criminology advertised its course offerings in the areas of law and justice. This attracted a number of students interested in legal education, and aiming at a law career. It is now felt that it would be desirable to set up a suggested study plan, grouping the required and elective courses at both the lower and upper levels, for students interested in majoring in criminology with a concentration on legal studies.

This requires the addition of some new courses that are currently being offered by other Departments (and which are particularly relevant to the future law student) to the courses listed in Group B, both at the lower and upper levels. These new courses will add considerable breadth to Group B, and will allow the student majoring in criminology a wider variety, and a greater number of courses from which to choose. It will also make it possible for criminology majors to acquire a still stronger interdisciplinary background. The list of the courses to be added is attached.
