March Meeting

1967

1. Canada Council Awards

Senate congratulated three members of Faculty on gaining Canada Council Awards: G.L. Bursill-Hall, F. Candelaria and S. Cooperman.

2. Congregation

The President said that he expected to be able to announce the name of the Congregation speaker in a few days.

3. Election of Three Student Representatives to Senate

Senate considered the report of the Committee to recommend procedures for the Election of Three Student Representatives to Senate. The Report was accepted with minor alterations. The approved regulations will be published in 'The Peak' and are posted on the Registrar's Bulletin Board and on the Bulletin Board in the Student Council chambers.

The election will take place over the next few months in order to allow the seating of the three student representatives at the June meeting of Senate.

4. Report of Senate Committee on Scholarships and Awards

T.B. Bottomore, Chairman of the Senate Committee on Scholarships and Awards, presented a lengthy report from the Committee which outlined the scholarships and awards and bursaries which had been awarded since the opening of the University. This report is available from the Financial Aid Officer in the Office of the Registrar.

5. Request for Senate Minutes - Academic Board

Senate decided to send the Minutes of Senate to the Secretary of the Academic Board as had been requested. The Academic Board of the Province of British Columbia receives the Minutes of the University of Victoria and of the University of British Columbia.

6. Student Records and Secondary Schools.

The Senate approved a policy of requesting students to sign a release form authorising the Registrar to send the student's record back to the high school from which he graduated. The University has been requested on a number of occasions to send the records back automatically but the recommendation of the Registrar and of the Student Society Executive was that only those records which had been released by the individual student be sent to the high schools.

7. Candidate for M.A. Degree.

The Senate awarded the degree of Master of Arts to G. Mercer, PSA Department.

8. Candidates for M.Sc. Degree.

The Senate awarded the Degree of Master of Science to Choy-Leung Hew in Chemistry and D.G. Wallen in Biology.

9. Regulations regarding Graduate Theses and Dissertations.

The regulations regarding Graduate Theses and Dissertations which had been recommended by the Senate Committee on Graduate Studies were approved by Senate.

Copies of these regulations may be obtained from the Registrar or the Librarian.

10. Law Enforcement Officers on Campus.

The attention of Senate was drawn to statements in the student newspaper and the City Press concerning the questioning by alleged law enforcement officers of a student on campus.

The Senate decided that the matter should be treated as outlined in the Universities Act, Section 61(2), which clearly gives the right of any student who feels himself aggrieved to make a complaint through the President to the proper governing body.
