This report summarizes the undergraduate enrolment outcomes of fiscal year 2021/22 and the proposed enrolment plan for 2022/23. A brief description of the terms used in the enrolment plan is given below:


- **PFTE:** An undergraduate program FTE (PFTE) is calculated by accumulating all undergraduate units taken by all students in each undergraduate program and dividing by the applicable full-time load for each program.
- **AFTE:** An activity FTE (AFTE) for a Faculty is calculated by multiplying the number of units for every course offered by the Faculty by the number of students in every course and dividing by 30.
- **COOP:** a Co-op term is defined as a full load for the purpose of counting undergraduate FTEs starting in 2011/12. This definition is consistent with other research universities. The definition of Co-op as full-time was already in effect for graduate students starting 2010/11.

2021/2022 Enrolment Outcomes

Funded Domestic¹ Program FTEs (PFTEs):

Program FTEs are dependent on retention of existing students, student credit load, recruitment of new students and the number of students graduating. SFU was funded for **17,274** domestic undergraduate full-time equivalents (PFTE) in 2021/22 including Co-op FTEs and 100 new FTEs for the Sustainable Energy Engineering program based in Surrey (a total of 320 PFTEs over 5 years). Our PFTEs were **18,119** -- a surplus of **4.9%** (845) above the Ministry's funded PFTEs. Our enrollment planning is done in terms of program FTEs excluding Co-op. We had **16,519** domestic undergraduate PFTEs this year (excluding Co-op), close to 1% above our enrolment plan. Graph 1 compares the 2021/22 program FTE plan versus actuals for SFU faculties.

Graph 1: Domestic 2021/22 Program FTEs Planned versus Actual by Faculty



¹ For the purposes of this report (undergraduate headcount, PFTEs, AFTEs), a domestic student is defined as someone paying the domestic tuition rate and an international student is defined as someone paying the international tuition rate. These numbers may differ from other reports (for example, the Enrolment Portal) where domestic/international differentiation is based on visa status.

New Domestic Student Intake: We admitted **5,307** new students which was **9%** above our new domestic intake target. (See Table 1 for 2021/22 Senate Approved Plan for undergraduate domestic full-time equivalent enrolments versus actuals and new intake targets versus actuals by Faculty). The softening of domestic numbers seems to have been reversed to some extent during the pandemic years; applications from new domestic students have been strong, most likely because students are not taking a gap year after high school and not pursuing out-of-province admission offers as much as they did pre-pandemic.



International Program FTEs and New International Student Intake: International student enrolment in 2021/22 was **4,717** PFTEs which equals **22.2%** of total undergraduate student PFTEs. See Graph 2 for international program FTE plan versus actuals for SFU faculties. We admitted **1,452** new international students, almost the same as established in last year's plan. (See Table 2 for 2021/22 Senate Approved Plan for undergraduate international full-time equivalent

enrolments versus actuals and new intake targets versus actuals by Faculty). This was a challenging year for international students due to the continuing pandemic-related travel restrictions. We were aware that the impact of the pandemic on the FIC pipeline would likely to be felt this year and in 2022/23. We did see a decline in new intakes from FIC to 764 students, whereas in the past 3 years we had recruited 1,100-1,200 new students from FIC each year. We continued to recruit strategically from a highly qualified pool of international applicants from B.C. high schools, and post-secondary transfers but this pool was also limited due to the pandemic.



Program FTEs and New Student Intake Trends: (See Graph 3 and Table 3 for details). Over the past five years, including 2020/21, we have had well-qualified pool of international applicants from B.C. high schools and post-secondary institutions, including FIC, resulting in strong international enrolment

outcomes. SFU felt the negative impact of pandemic-related global decline in international enrolments this year and this trend is expected to continue next year. The enrolment of international high school students in SFU's local catchment schools declined during the pandemic and FIC enrolments have been impacted despite a number of measures taken by FIC to recruit and retain students. It is likely that the global international student market would bounce back as many countries are easing travel and entry restrictions for students. On the contrary, the softening in the domestic applicant pool which SFU had been experiencing for the past few years, partly due to the demographics of declining university-aged population in our catchment areas and partially due to increasing competition from teaching- and research-intensive universities, moved in a positive direction. SFU surpassed the domestic intake target in 2021/22 and also achieved/exceeded the PFTE targets over the past two years. More domestic students enrolled in remote classes and took a slightly higher average credit load during the pandemic but these trends are coming back to pre-pandemic levels now. Admission GPAs were adjusted mainly for international students where there was capacity to recruit strong students from local post-secondary transfer institutions and local and international high schools, but these adjustments did not result in admissions below comparable admission GPA's for domestic students.

2022/2023 SFU Enrolment Plan

The Simon Fraser University Enrolment Plan (see Appendix A: Key Tables from the 2022/23 SFU Proposed Enrolment Plan) shows *actual* student enrolments of 2016/17 and 2021/22, proposed *target* enrolments for 2022/23 and *long-range enrolment targets for 2026/27*. SFU's Enrolment Planning Strategy:

Undergraduate: With respect to undergraduate enrolment, the 2022/23 planned Co-op and non-Co-op undergraduate PFTEs enrolment is proposed to be **17,991** (Section 4p) which would be **4%** above the

Ministry funded program FTE of **17,274** and along the lines of the long-range enrolment plan of 4-5% above the funded target.

As shown in the SFU Enrolment Plan, the 2022/23 undergraduate funded program FTE target for domestic students (excluding Co-op FTEs) is **16,391** PFTEs (see section 6p of the SFU Enrolment Plan). The proposed international FTE target (excluding Co-op) for 2022/23 is **4,775** which equates to 22.6% of all undergraduate FTEs (see section 7p of the SFU Enrolment Plan). Based on the university and faculty enrolment plan, it is estimated that we need to admit **5,064** domestic and **1,520** international new students to meet this enrolment plan. See Table 4 below for a breakdown of the enrolment plan and new intake targets by faculty.

Appendix C provides further details of proposed new domestic and international student intake targets for 2022/23 using the basis of admission categories of Secondary, Post-Secondary and Other.

Graduate: The Graduate enrolment plan is established for Regular and Specialty graduate programs. Regular graduate programs generally charge a semester tuition fee, while the Specialty programs generally charge a per credit tuition fee. In 2021/22 SFU received Ministry funding for **2,927** graduate PFTEs (including Co-op) and 30 new FTEs for the SEE program (a total of 120 FTEs over 5 years) and generated a surplus of 655 PFTEs. Note that our methodology for calculating graduate surplus has changed as per reporting requirements from the Ministry. We now exclude the PFTEs related to international students in programs with a differential graduate fees and include domestic Digital Media program. Including all graduate programs, we were **22%** above the Ministry's funded targets in 2021/22.

Graduate AFTE enrolment in 2021/22 was almost 6% higher compared to the previous fiscal year, (Specialty AFTEs (9.5%) and Regular AFTEs (2%)). Graduate headcounts were almost 3% higher than last year; new student headcounts were 19% higher than the previous year making a good recovery after the low numbers in 2020/21.

Graduate Enrolment Plan: Due to high demand for graduate programs and being a research-intensive university, we are planning for 3,735 PFTEs (excluding Co-op) or 3,633 non-Co-op activity FTEs (AFTEs). This breaks down to **1,956** AFTEs (excluding Co-op) for Regular and **1,677** AFTEs (excluding Co-op) for Specialty for 2022/23 (Tables 13a & 14a in Appendix A). The long-range graduate enrolment plan translates into enrolment targets of 2,192 AFTEs (excluding Co-op) for Regular and 2,075 AFTEs (excluding Co-op) for Specialty in 2026/27.



For EDUC, the new intake targets include students who are only new to SFU and new to the Faculty of Education. This Plan includes PDP intake targets of around 340-390 students. Based on recent data we expect 39%-41% students to be new to SFU and 59%-61% would be SFU students joining the PDP program.


