C U R R I C U L U M C H A N G E S

91 GENERAL PROGRAM

FROM:

- d) A minimum of 30 semester hours outside one's Arts Major program;  
(Note: Courses taken outside one's Major program as part of the Group Requirements, i.e. a), b), and c) above, may be counted toward requirement d).)

TO:

- d) A minimum of 30 semester hours outside one's Arts Major *department*;  
(Note: Courses taken outside one's Major *department* as part of the Group Requirements, i.e. a), b), and c) above, may be counted toward requirement d).)

p. 92 HONORS PROGRAM

FROM:

- d) A minimum of 30 semester hours outside one's Arts Honors program;  
(Note: Courses taken outside one's Honors program as part of the Group Requirements, i.e. a), b), c) above, may be counted toward Requirement d).)

TO:

- d) A minimum of 30 semester hours outside one's Arts Honors *department*;  
(Note: Courses taken outside one's Honors *department* as part of the Group Requirements, i.e. a), b), and c) above, may be counted toward Requirement d).)

RATIONALE:

In the discussions of changes to the Faculty of Arts Group Requirements which were made in 1975 the Committee discussed requiring at least 30 hours outside the Major or Honors department for a B.A. degree. However, in its written form, the regulation continued to read program. The present Committee agreed that requiring 30 hours outside the Major or Honors department was in keeping with the philosophy of breadth espoused by the Faculty in its present regulations.

p. 91 GENERAL PROGRAM

FROM:

\*A department may designate up to 8 credit hours of upper division courses offered by other departments, as being acceptable in fulfilling part of this requirement.

TO: \*A department may designate up to 8 credit hours of *program related* upper division courses offered by other departments, as being acceptable in fulfilling part of this requirement.

p. 92 HONORS PROGRAM

FROM:

\*A department may designate up to 12 credit hours of upper division courses offered by other departments, as being acceptable in fulfilling part of this requirement.

TO:

\*A department may designate up to 12 credit hours of *program related* upper division courses offered by other departments, as being acceptable in fulfilling part of this requirement.

RATIONALE:

This change is to indicate that courses designated by departments or programmes as fulfilling a portion of the Major or Honors requirements are expected to be related to the Major or Honors programs.
